Objectives, scope and criteria:

Vinçotte performed on behalf of DEME an independent limited assurance of the anthopogenic greenhouse gas emissions between 01/01/2022 - 31/12/2022. The system boundaries for the greenhouse gas emissions are aligned with the financial consolidation scope.

The entities within the system boundaries are located in Belgium, The Netherlands and Luxemburg. Following activity lines are part of the system boundary:

- DEME Dredging
- DEME Infrastructure
- DEME Environmental
 - DEME Environmental
 - Ecoterres
 - o De Vries & Van De Wiel
- DEME Offshore

The activities and processes considered for the greenhouse gas inventory are buildings, transport of people (lease cars), machinery & equipment, vessels (RMPE excluded) & auxiliary floating equipment.

The greenhouse gas inventory includes scope 1 and scope 2

- Scope 1 emissions: direct energy consumption, lease cars
- Scope 2 emissions: electricity consumption and other indirect energy consumption (such as district heating);

The greenhouse gasses included were: CO₂.

In the context of the CO2 performance ladder (niveau 5) the following emission sources were excluded from the carbon footprint: lubricants, air conditioning refrigerants, cutting & welding gasses, and scope 3 emissions. Data from the RMPE vessels that already is verified by IMO was excluded from the verification.

The data and information for the greenhouse gas inventory were based on documented information received from local responsables registered in Apprise and Sharepoint.

The verification consisted of an independent review of the primary data, the emission factors and the greenhouse gas calculations. The goal was to verify if the data and the results of the greenhouse gas calculations were complete, reliable, transparant accurate and free of material errors or emissions.

The verification was performed using a risk-based approach. For all other data a verification was performed taking into account materiality.
